Scholarships are available to qualifying need-based students ages 7-18 with a serious interest in learning music.



### BLANKENSHIP MEMORIAL PROJECT

#### **MISSION**

The Blankenship Memorial Project is a scholarship program that provides need-based financial aid to qualifying students who wish to sing or play any musical instrument.

#### **BACKGROUND**

This project is named in memory of Walter Blankenship, a young amateur pianist who passed away in 1996. Since he loved playing the piano, as well as helping children, his widow and friends thought this would be a fitting tribute to his life.

A piano was purchased from the memorial fund organized by Walter's friend, Roger Ide, and placed in the Livermore Gardens Apartment Building. The scholarship came to life with a donation to cover lessons for two months. Since then, the project has grown to include all residents of the Tri-Valley Area.

This project, founded by the Music Teachers'
Association of California, Alameda County East
Branch, offers music lessons to students from ages 7
to 18 years old. Financial aid is awarded based on
household income eligibility.

Weekly lessons taught by only certified members of the MTAC Alameda County East Branch will be provided at a low cost to the student's family.

#### **ELIGIBILITY**

Open to legal residents of the U.S. ages 7-18.
Requests for financial aid must be accompanied by one of the following: your most recent federal tax return, public assistance documentation, proof of participation in the free/reduced lunch program, or unemployment verification.

#### **SELECTION PROCESS**

Students will be selected by a combination of their interest in learning their chosen instrument, coordination on beginning exercises shown to them, and a listening test. The student must also submit a letter of recommendation from one of their teachers, counselors, or principals.

#### **COSTS INVOLVED**

The music lessons will be provided by qualified teachers at a reduced rate, depending on need. Instruments can be provided for rent or a donated instrument will be lended to the student if available. Parents are responsible for managing rental payments and arranging for delivery times.

Please specify in your application if a rental will be needed.

#### TIME COMMITMENT

One 30,45, or 60 minute lesson per week will be provided to each student. A minimum of half an hour of practice per day, six days a week is required. Continuation in the program is dependent on the student practicing consistently as stated above. The student may be dropped from the program due to insufficient practice and/or two or more unexcused absences.

#### MISSED LESSONS

Two lessons may be missed every six months without penalty. If a third lesson is missed, the student will be put on probation. If another lesson is missed, they will be dropped from the program and their place will be given to another student.

## FAQ

#### WHAT TYPES OF MUSIC WILL BE TAUGHT?

The students enrolled in the scholarship program will learn a variety of musical styles from Folk songs,

Classical, to popular tunes.

## HOW LONG DOES IT TAKE A STUDENT TO ADVANCE THEIR SKILL LEVEL?

Music students begin with different abilities and learning styles. Generally, it takes at least three to four years before a student is considered intermediate and eight to nine years to begin advanced level pieces. It is a long-term commitment. This program is for students who want to commit to learning for years, rather than months.

## MAY MULTIPLE CHILDREN IN THE SAME FAMILY RECEIVE A SCHOLARSHIP?

If multiple children in the same family are between the ages of 7-18 with an interest in learning to sing or play an instrument, they are both welcome to apply for the scholarship.

#### WHAT IS THE SCHOLARSHIP VALUE?

Private music lessons in the Tri-Valley Area range from \$30-\$90 a week depending on the experience and education of the teacher. The student will be studying under a qualified MTAC-affiliated teacher.

Instrument rentals can range from \$50-\$200 a month, but arrangements can be made for Blankenship funds to cover a portion of this amount.
